

MILFORD SENIOR CENTER EVENTS PROVIDING ALCOHOL

The Gathering License issued to us by the Alcoholic Beverage Control Commission requires that the Milford Senior Center purchase **all** alcohol that is consumed on the premises. Liability requires that **we** employ licensed bartenders to serve alcohol on the premises. Any renter or guest who does not abide by this policy will be asked to leave the event. Guests may be asked to provide proof of age at the bar or may be refused continued service if the bartender or owner deems such guest to be inebriated beyond the safe limits of consumption. The renter must provide safe passage to anyone unable to drive home from the event. The owner and/or bartender also reserves the right to close the bar and cease service at his or her sole discretion should it be warranted. There are **no** Sunday alcohol events.

Items of interest concerning the bar:

- 1) Bartender fee is a minimum of \$100.00 per 4 hour event. Any additional hours beyond the scheduled four hour event will incur a fee determined by the bartender. One bartender is sufficient for groups up to 100 people: two bartenders are required for groups larger than 100 people. NO alcohol will be allowed without the services of a bartender. Alcoholic punch must be labeled as such and served from near the bar.
- 2) Bar Service includes fountains with alcohol punch, bridal toasts at the tables, cash bars, open bars, tab bars and mixed cash and tab events. Alcoholic punch must be labeled as such and served from near the bar. Renter may choose the type of bar required for the event.
- 3) The owner will attempt to fill any special orders of alcohol beyond normal stock. Three weeks notice is required for special orders.
- 4) Disposable champagne glasses are available for \$.40 each. Owner will assemble them for caterer to place on tables.
- 5) All non-alcoholic beverages may be purchased by the renter and stored in Center refrigeration after 3:00 pm the day prior to the event. Cups for non-alcoholic beverages will be provided by the renter. Sodas are not offered at the bar unless arrangements have been made with the Director of Marketing. Sodas through the bar are \$1.00.
